The Board interviewed two candidates for the Middle School Principal position and discussed the appointment of the new Principal. Discussion ensued.

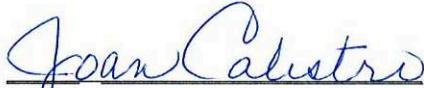
