Call to Order:

The meeting was called to order at 6:00 PM by Chairman Belanger.

Approval of Minutes:

STEVE MARTINO MADE A MOTION TO APPROVE THE MINUTES FROM THE JANUARY 23, 2017 MEETING. KEN RESTELLI SECONDED THE MOTION. THE MOTION PASSED UNANIMOUSLY. THE MOTION CARRIED.

Chairman Belanger moved items 4 and 5.

Presentation of Wheeler School Design Plans for Committee's approval:

Scott Mangiagli from KBA gave a presentation regarding the school design and upgrades for the Wheeler Project. The State determined that in order for the project to receive the maximum reimbursement rate of 65%, they should proceed with 'renovate as new' status. He met with the Principal, Superintendent and Teachers and determined that with programmatic changes the building could be made better without adding square footage. There will be only 1 addition to the project and that will connect the two wings of the building. They have moved the bus loop to the side where the parent drop off is which will make a safer drop off of all students. Some of the rooms will be relocated without adding space. Mr. Busel asked if there was anything in the project to upgrade the fencing around the play area. Some of the fence is in disrepair and could use an upgrade. Mr. Mangiagli stated at this time there is nothing specific in the project to replace fencing, however, he will look into it for Mr. Busel. Discussion continued.

MSP Roofing Project:

They plan to replace the existing roof with a PVC roof. This will get a warrantee without replacing the entire metal roof structure.

PHS Paving Project:

There are plans to replace curbing, asphalt and the drainage system will be replaced; it is a standard parking lot replacement.

There would be no increase in the Debt Services. Discussion continued.

Review of Budget and Estimates:

Ken Biega from O&G reviewed the Schematic Design Estimate and cost summary for the projects. He also reviewed with the committee how the reimbursement rate is determined. Not everything on the project is eligible for reimbursement, after the change orders are signed off on, the State will determine whether the item is eligible. He then reviewed the next steps when the referendum is passed on June 6th. KBA will complete the design drawing, the final estimate will be developed and the project will go out to bid. Discussion continued.

Discussion regarding the replacement of the MSP roof:

Chairman Belanger stated that it was brought to the Committees attention that if we replace the roof at the MSP and then go for 'renovate as new' within 5 or 10 years from now we will need to take the roof off and he feels it would be a waste of taxpayer money. Chairman Belanger asked Mr. Busel who has been exploring other options to speak to it.

Mr. Busel stated that he had met with Mr. Boos and discussed the options for the MSP roof. They can do a restoration of the existing roof or a maintenance plan. Mr. Busel has had contractors look at the roof and they stated for its age, it is in good shape. A restoration would

guarantee the roof for 15-20 years at a cost of approximately \$600,000. He can do a maintenance plan for approximately \$5,000 per year. The committee reviewed the contact wording. Discussion continued.

STEVE MARTINO MADE A MOTION TO RECOMMEND TO THE PLAINVILLE TOWN COUNCIL THAT THEY REMOVE THE MIDDLE SCHOOL ROOF FROM THE PROJECT. RICHARD NEGRO SECONDED THE MOTION. THE MOTION PASSED UNANIMOUSLY. THE MOTION CARRIED.
