Approval of Minutes:

Request Committee approval to bring Wheeler documents to State meeting on April 3, 2018:

Mr. Mangiagli met with Town official's this morning to ask them to sign off on the State documents that he will bring to the State meeting on April 3 with the Department of Administrative Services. All documents have been stamped, these documents are the ones the State will review allowing the project to move forward and go out to bid. He informed the Committee that it should be a long meeting; the State will tell them if there is anything missing. Mr. Mangiagli feels they are 100% ready to meet with the State for their approval to move forward to have O&G go out to bid. If the State does find something that needs to be added, it will delay the approval process about one week. Mr. Mangiagli stated that the signature requirements needed for the SCG 042 that will go to the State are Andrea Saunders, Board of Education Chairperson, Dr. Maureen Brummett, Superintendent and Mark Belanger, CPBC Chairman. There are no surprises regarding the Haz/Mat testing. They will finalize their plans this week and go to the State. All mandatory testing has been performed. Discussion continued.

## Other:

Mr. Busel invited William B. Meyer Moving, Inc. to Wheeler School to give them a cost estimate for their services to move items and boxes into either a storage facility or into the gym. They are working on numbers that Mr. Busel would be able to present to the committee. Mr. Busel is very comfortable using Meyer Moving. He stated that Meyers does about 90% of the school moving for projects and they are on the State contractors bid list. Mr. Busel and Mr. Sedensky have spoken with Paul Kennedy from Meyers Moving and he gave them a quote for \$2,100 to drop off boxes tomorrow. In order to provide the boxes for the project they are requesting that the Committee approve a motion not to exceed \$2,500. Discussion continued.
