B&W Paving and Landscaping base bid is \$1,245,000.00 and Mizzy Construction base bid is \$1,376,000.00. After discussion regarding the bids and alternates by the Committee there were questions they felt that needed to be answered. The Committee will table the discussion and ask KBA who designed the project to attend the regular CPBC meeting on Monday, June 25 @ 6:00 pm in Room 302 for discussion and clarification.

## **Demolition Bid Review for the Wheeler Project:**

O&G has completed its scope review of the Demolition and Abatement package for the Wheeler Project. The lowest qualified responsible bidder is Select Demo Services, LLC with a base bid of \$685,000.00. If approved by the Committee, they will be organized and ready to begin demolition and abatement after July 4, 2018. Discussion continued.
