The meeting was called to order at 6:00 pm by Vice Chairman Steve Martino.

Approval of Minutes:

Update on the WPCF Phosphorus Upgrade Project

Mr. Alosso stated that the project is on schedule for completion in February 2020 and then punch list items will be completed. He then reviewed the Change Orders associated with the project for this month.

CR-59: Conservation / Wildlife Seed Mixture

Please see the attached price to apply the Conservation / Wildlife Seed Mix to the sloped area to the north and east of the Filter Building, along the fence line. Please note this seed mix will not be applied via hydro seeding as the rest of the site would be. Per this proposal this smaller amount of seed would be broadcast and Penn Mulch applied to the area (opposed to hydro mulch). The CR-59 is in the sum of \$3,090.02.

On October 29, 2019 Mr. Alosso received an additional quote from a local landscaper Green Earth for the same services in the sum of \$1,800. Green Earth will be on site this weekend to do the work. This will keep with the current schedule and application times.

CR-26A: Wiring of New Devices to LCP-4 rather than SBR CP

It was recognized by Chris Knapp and Ron Smith were together on site on September 12th that the change made to CR-26 (to bring the eight new signals to LCP-4 rather than the SBR Control Panel) is not possible without installing an additional input module in LCP-4. The CR-26A is in the sum of \$4,443.17.
