Call to Order:

The meeting was called to order at 6:00 pm by Chairman Mark Belanger.

#### **Approval of Minutes:**

STEVE MARTINO MADE A MOTION TO APPROVE THE MINUTES FOR THE REGULAR MEETING ON OCTOBER 28, 2019. RICHARD NEGRO SECONDED THE MOTION. THE MOTION PASSED UNANIMOUSLY. THE MOTION CARRIED.

## Update on the WPCF Phosphorus Upgrade Project

Mr. Alosso stated that the project is on schedule for completion in March or April 2020 and that the project is going very well. Mr. Siegal from Tighe & Bond then reviewed Change Order # 26A that was tabled pending more information from the last meeting.

## CR-26A: Wiring of New Devices to LCP-4 rather than SBR CP

It was recognized by Chris Knapp and Ron Smith, who were together on site on September 12<sup>th</sup>, that the change made to CR-26 (to bring the eight new signals to LCP-4 rather than the SBR Control Panel) is not possible without installing an additional input module in LCP-4. The CR-26A is in the sum of \$4,443.17.

Mr. Seigal stated that there was new instrumentation that needs to be added that would add enhancements to the project. The company involved wanted to charge the project \$90,000 to do the work. The in-house programmer said there is a much simpler solution and the cost would be much less. He determined the cost of the upgrade would be \$4,443.17. After discussion, the Committee was satisfied and moved forward to approve Change Order #26A.

Mr. Alosso then submitted an additional Change Order #CR-60.

### CR-60: Revised Bid Item #6 Unit Price

Bid item #6 on the Form for General Bid is Contaminated Soil Transportation and disposal, per ton. The contract cost for this unit price item is \$400/ton. The estimate quantity per the bid documents was 500 ton. Per section 00700 General Conditions, part 13.03 Unit Price Work, subsection E, the contractor or owner may seek an adjustment in the contract unit price after determination of actual quantities and classification of Unit Price Work.

Based on the soil test results dated 9/26/19 and 10/9/19 and the overall determined quantity of polluted soil to be removed from the site of approximately 1020 tons, Daniel O'Connell's Sons would like to offer a revised unit price of \$70/ton.

For this unit price Daniel O'Connell's Sons will assume all responsibilities for the polluted soil. Handling of the polluted soil including transportation and disposal would be completed in full accordance with all requirements of specification section 02120 as submitted in submittal 02120-01.

If this revised unit price is accepted and Daniel O'Connell's Sons perform the work of hauling and disposing of the estimated 1020 tons of polluted soil, DOC will consider CR-17 to be void.

## O&G: Update on the Wheeler School Project

Mr. Sedensky reviewed with the Committee the Monthly Progress Report No. 8. He reported that Phase 1, Phase 1A (Mechanical Room) are 100% completed. Phases 2, 2A and 2B are 99% complete. They are still working on Phase 3 with 70% completion. The additional corridor that was added connecting the wings is 100% complete and sitework is 97% complete. The project is moving along nicely. He also reported the project is on budget. The CM Construction Funds available are approximately \$277,355.00 and the CMR or owners funds available are \$689,494.00. Mr. Sedensky feels that the project is on schedule and under budget. The PreK classrooms will be turned over to the school after the Holiday break and the punchlist is ongoing. Discussion continued.

This summer at Wheeler and other projects, Select Demo cannot properly man the project to perform this additional work within the timeframe required to maintain schedule. #2. Mizzy COR #20: Cost to remove ACM material at brick infill and repair at west boiler room and north kitchen elevations. PCO 00060.2 is in the sum of \$0.00.

Verify top rung is at least 4" below the line of ceiling but not more than 12" below the attic floor level.
