The meeting was called to order by Chairman Belanger at 6:00 PM.

The recorder informed the committee that there will be an OPEN HOUSE of the Newly Renovated Frank T. Wheeler Elementary School on Wednesday, March 4, 2020 from 6:00 – 7:30 pm. She asked if there was anyone from the Committee who would like to speak. Chairman Belanger asked Tom Arcari if he would say a few words from the Committee and Mr. Arcari agreed to speak that evening.

Approval of Minutes:

RICHARD NEGRO MADE A MOTION TO APPROVE THE MINUTES OF THE JANUARY 27, 2020 REGULAR MEETING. STEVE MARTINO SECONDED THE MOTION. THE MOTION PASSED UNANIMOUSLY. THE MOTION CARRIED.

Update on the WPCF Phosphorus Upgrade Project

Mr. Alosso stated that the project is going well and we are about 95% complete. Most of the trailers are off site but will return again when work picks up the first or second week of March. According to the contract, the project should be completed by July 2020. However, Mr. Alosso feels the completion date for the project will be April 1. He is still working with Tighe and Bond regarding the Change Order CR-66 for Additional Filter Building Grating Modifications that were discussed at the January 14, 2020 meeting. He hopes to have more information regarding that Change Order and a Payment Application for the Committee to review prior to the meeting scheduled for February 24, 2020. Mr. Alosso brought forward for the Committee to review several change orders.

CR-63: Calibration Column at Polymer System

This is for adding a calibration column to the filter polymer system, which wasn't shown on the drawings. We discussed this issue in the field, and went ahead and did it without submitting a price. The hours are correct and the price seems reasonable for the work. The change order is in the sum of \$590.34.

CR-70: Magnesium Hydroxide Shaft

This is to address both the splashing/staining and evaporation at the magnesium hydroxide tanks. There was discussion with the tank supplier and the chemical supplier that confirmed a solution to the present problem. Split rings and gaskets will be added to each of the tanks to avoid evaporation. The change order is in the sum of \$3,477.67.

This was a request to install 2 vents at poly tanks not shown on prints. This change order is in the sum of \$1,454.78.

CR-72: Furnish and install 2 channel Rubber Electrical Wire Cable Covers

This will protect the fuel piping at the floor in the filter building boiler room. This change order is in the sum of \$155.61.

He mentioned that they thought there might have been a water issue but discovered that the lines were just not properly flushed. He had the Company flush the lines again and the issue is resolved. Mr. Sedensky has two change orders that he would like to present for approval this evening. He will also have a monthly report ready for the Committee to review at the next meeting.

PCO-00120: Add Rinse Sink and Pipe Cover

This was requested by the Food Service Director to add a rinse sink in the kitchen and add a pipe cover only at the prep table sink. This change order is in the sum of \$8,366.00.
