## **DIRECTORS REPORT:**

CONSTRUCTION REVIEW: WORK ON THE PARKING LOT WAS SUPPOSED TO START ABOUT MARCH 17 BUT BECAUSE OF "NSTRUCTION DELAYS WORK WILL NOW BEGIN NEARER TO AN APRIL DATE. ALL PROGRAMS WILL BE SCHEDULED AS ACE IS AVAILABLE.

NEW DIAL-A-RIDE BUS: WE WILL BE MAKING A DECISION BY 3/15/16 ON ALL FEATURES NEEDED FOR OUR NEW BUS. THIS NEW BUS IS FUNDED BY A GRANT WE RECEIVE. WHICH PAYS 80%, TOWN OF PLAINVILLE PAYS 20% UNDER OUR CAPITOL PLAN. UP UNTIL NOW THIS BUS IS REPLACED EVERY 5 YEARS, AFTER THIS NEW BUS THE REPLACEMENT WILL BE EVERY 4 YEARS.

MUNICIPAL AGING GRANT: THIS GRANT PROVIDES FOR ALL OUR QUICK TRIPS, SHOPPING, SPECIAL DAY PROGRAMS. WE ALSO PROVIDE A NEW PROGRAM OF TWICE MONTHLY SHOPPING TRIPS FOR DISABLED OF ANY AGE AND ALSO FIELD TRIPS FOR CAMP TRUMBULL.

NCAAA FUNDING: THIS GRANT PROVIDES US THE MONEY TO CONTINUE OUR GRANDPARENTS PROGRAMS, ALSO FOOT CARE ETC. WE ARE ABLE TO GIVE THE GRANDPARENTS GIFT CERTIFICATES TO RESTAURANTS AND WARM COATS FOR WINER, ETC. EXTRA MONEY FOR MANY ITEMS THEY WOULD NOT BE ABLE TO AFFORD.
