I. G. Paderewski Pond – Sub Committee

Discussion:

- Shane Lockwood, CT Department of Health was present at the meeting.
- Shane said that there was a similar problem with the fish at a pond in Southington.
- Shane said that the Fishing Derby should be fine, but people should wash their hands. Water and soap would be best.
- Shane answered questions on bacteria levels in the pond. Shane said that the bacteria levels will be high because the water is stagnant.
- The bacteria levels will not affect the fish.
- Robert shared that additional testing would need to be done before dredging the pond.
- Robert explained the Town Council is considering using a vendor to spread a chemical to remove the weeds in the pond. It would be a significantly lower cost than dredging.
- Tammy reported a new twig coming out of the pond.
- A resident asked if there has been any thought given to a partial dredging.
- Robert said that loose dogs are an issue for the pond. He will ask the Dog Warden to check the area more often.

 - Marge asked for scotch tape for the envelopes.
 - Adults 18 and over will be the recipients of the seeds. They are not meant for human or animal consumption.

 The program will be in May to allow enough time to get the bags of seeds ready.

- Jeff, Randall, Marge and Roberta will help with the seeds.

E. <u>Fishing Derby</u> – Marge looked at the different options for stocking the pond. The commission discussed the options. The fish will be put back in the pond. 145 of the 8 inch trout, 40, 9 inch trout.
