VI. Staff Reports

Mark went over some information on what is happening in the Town of Plainville with the Agency.

- 1. 10 New Britain Avenue this property at the corner of East Street and New Britain Avenue, formerly owned by General Electric, has been leased by U-Haul. They do plan to purchase the building by March 24th and have begun advertising for self-storage within the building itself. Plans include large-scale renovations for a climate controlled self-storage facility. A small retail operation selling moving supplies as well as a vehicle leasing center are also in the works. Eventually, U-Haul wants to utilize the unused parking lot to establish a storage area for recreational vehicles. That use, as well as other site improvements will require formal approval by the Planning and Zoning Commission the various uses inside the building, are permitted by right.
- 2. Farmington Canal Heritage Trail Planning the process has begun and data gathering is now being conducted.
- 3. Ducci Electric have begun construction on a 25,000 square foot contractors facility.
- 4. Allstate Fire Equipment will be starting construction on their new facility at 70 Robert Jackson Way.
- 5. Northeast Produce continues to work on their 2,000 sq. ft. expansion.
