The applicant has requested a loan of \$40,000.00 with a term of five (5) years. The prescribed interest rate as of this writing is 2.33%. Mr. Petit thanked the Agency for previous assistance they have offered and provided a detailed overview of what AMP Radio Network wishes to do with the loan they are now requesting.

Since the last loan was awarded, Mr. Petit shared that AMP has purchased a new company, which also runs out of the Whiting Street location. They are engaged in website production and hosting. Amp has been doing very well and has garnered additional territory and would like to expand further by utilizing \$20,000 in AMP partner capital, and \$40,000 in loan funds to leverage their next level of expansion. Mr. Petit shared with the agency that he will hire one more full time sales person and one more part time person.
