# 2. Informal discussion with John Senese regarding 311-349 New Britain Avenue

Mr. Senese talked about the possibility of a tax abatement for his property. He shared the possible tenants he is proposing, although none are confirmed at this point.

John is looking for a 10-year tax abatement to secure tenants so he can better market the property to proposed tenants. The current and revised policy does not offer the level of abatement Mr. Senese mentioned. Mr. DeVoe stated that the EDA will be looking for a concrete proposal and that any resulting agreement would have to provide estimates of projects costs, job creation, and project timelines.

Mark Devoe explained to him that there is a process he must go through and he would send him the proper application forms. Mr. Senese must submit a site plan that staff can reasonably verify meets land use requirements.
