#### IV. New Business

 EDA 08/17 #006 – Tax Abatement Request for Royal Realty, LLC. (Walker Crane and Rigging) - 50 Farmington Valley Drive, Plainville, CT

Mr. Roy has proposed another expansion at his 50 Farmington Valley Drive facility. The extra space will be added to create additional storage for his current client base. The size of the proposed expansion is 22,500 square feet. Mr. Roy has exhibited a great deal of loyalty to the Town of Plainville, expanding in place seven times since the original structure was erected in 1998. The original facility was approved at 33,600 square feet. The facility size, after construction of the proposed addition, will be approximately 127,000 square feet.

Mr. Roy reports that their biggest customer TRUMPF, shows consistent growth of manufacturing laser, punch and press brake fabrication machines. TRUMPF needs Walker to store the used machines that they will refurbish and sell. Mr. Roy is out of room at his present location and is leasing space in another municipality so he needs to expand his building in Plainville to accommodate his customers' needs.

Mr. Roy reports that he has other customers that are expanding as well.

The cost of the improvements is estimated at \$1,800,000.00.

A motion was made by: Helen Bergenty to grant Walker Crane, LLC., Royal Realty a 40 % tax abatement for a period of 4 years for their 22,500 sq ft new addition.
