- A. <u>Fall / Winter Update Swim Team Participants declined to 45 participants, less than usual but still a great response.</u>

- C. After School Programs Courtney talked about the after school program that will be take place at Toffolon School. It will begin on January 5, 2022. It will be open for all 3 elementary schools from a grant program the BOE is providing, the kids will be bussed over to Toffolon for the program. It will take place Wednesdays and Fridays after school from 3:15 5:15 pm. Courtney posted the staff opening at the High School. One High School student was already interviewed for a position. The Recreation Department will train the staff. The cost of the staff will be reimbursed by the schools. There is no cost to the children that participate.
- **D.** Winter / Spring Flyer Courtney is working on it. There will be a Zumba program and adult basketball programs included.

- E. <u>Paderewski Park</u> Ezio and Courtney talked about the park and concerns for safety in the tennis court area and the field area. Courtney to meet with Town Staff. They will come up with a list of possible solutions. There are also concerns about Paderewski Pond and fishing, per the Conservation Commission. Discussion followed.
