The FAA should be giving formal approval in April.

Property/Building Assessment Discussion

Mr. Walsh said that four hangers are being surveyed and is working with staff to finalize. The draft should be ready in April. Mr. Walsh will email the draft to Scott Colby for distribution to the commission members.

Interstate Aviation Report

Lynn from Interstate Aviation reviewed the numbers for February 28, 2019. There were 33 planes in tie-downs. As of February 28, 2019 fuel sales were 100LL – 1484.2 gals; Jet A sold 398.0 gals. There were 0 overages.

Nick said that he was approached about using Hanger 1 for a fundraiser in May 2020. Liability will be discussed if the fundraiser is confirmed.

Proposals to paint the hangers were discussed as this is something that needs to be done. A preliminary estimate for \$25,000 would include power washing and use of durable paint guaranteed for 20 years. Reviewing the lease will determine who is responsible for what.

Any Other Items

June 8th is the date for Wings and Wheels.

IV. Public Comment

Mr. Corlis said that everything is on track and to keep going at this pace. Progress is being made.
