Call to Order:

The meeting was called to order at 6:00 PM by Chairman Mark Belanger.

Approval of Minutes:

RICHARD NEGRO MADE A MOTION TO APPROVE THE MINUTES FROM THE MEETING THAT WAS HELD ON JUNE 27, 2016. TOM ARCARI SECONDED THE MOTION. THE MOTION PASSED WITH 5 YES VOTES AND 1 ABSTENTION (MR. TUFTS ABSTAINED FROM VOTING). THE MOTION CARRIED.

Chairman Belanger moved Item 4 on the agenda, Review of Preliminary Energy Assessment prepared by ECG Engineering Firm to Item 3. He asked Edward Hoyt, Consultant for ECG to introduce Aldo Mazzaferro, Director of Project Development for ECG.

Mr. Hoyt explained that after working with ECG and understanding what they did as energy contractors, he had a conversation with Robert Lee that it might be of value to bring the company on board with some opportunity for savings on the school projects. Ultimately, ECG would like the committee to recommend to the Plainville Town Council that they allow ECG to do a Feasibility study that could determine potential savings for the proposed projects at the Middle School, Wheeler and High School parking lot. The Feasibility Study will have no cost to the Town connected with it. Discussion continued.

Mr. Mazzaferro explained to the committee that ECG Engineering is a specialist in Energy Savings performance Contract (ESPC) Technical Consulting, evaluation and design. They have over 100 ongoing projects in New York, Connecticut and Pennsylvania and all projects have met or exceeded guaranteed energy savings. They have local clients in Thomaston, Cheshire, Southington, Waterbury, Gilford and Shelton. An Energy Savings Performance Contract is a partnership between a Municipal Agent and an Energy Services Company that makes needed building improvement now to be paid for in the future with guaranteed energy savings. There are no out of pocket costs and no risk. Mr. Mazzaferro reviewed the Energy Performance Contract and its benefits:

- Time and Cost effective approach to Facility Upgrades
- Leverage future energy savings to fund Facility Upgrades
- Guaranteed energy savings reduces financial and performance risk
- Turnkey, one-stop-shop approach = single point of accountability
- Frees up Capital Budget Dollars for allocation to other needs
- Does not require a tax increase

He then reviewed what the next steps would be to get started:

- Plainville would need to authorize ECG to issue an RFP to Energy Services Companies
- Approximately 2-3 months after RFP Kick off, ECG and winning ESCO will present preliminary scope of work to the Capital Projects Building Committee.
- These steps require no obligation and no cost to the Town of Plainville.

Discussion continued.
