

TOWN OF PLAINVILLE CONSERVATION COMMISSION
Meeting held on October 14, 2015

The meeting was called to order at 7:30pm.

In attendance were Marguerite Burris, Roberta Lauria, Randall Paz, Eric Levy and Lisa Lozier. Leslie Sundell was unable to attend.

Dave Emery was asked to come to the meeting and in order to let Dave get home the meeting agenda was waived by a motion from Lisa Lozier. Randall Paz seconded and all were in favor.

Dave reported that the dead fish from the massive fish-kill at Paderewski pond had been cleaned from the shores. In regards to the containers for discarded fishing line, Eric had given him a list of materials needed to construct 4 of these containers. Dave was going to check with Comp-U-Sign to see about signage/stickers to put on the units. When he gets the materials he said he would drop the items off at Eric's house. Rather than rush since there was such a significant die-off and it's heading into winter, it was decided to put these up in the spring. The only item on the list that Dave said he would hold off purchasing now was the concrete.

Lisa Lozier made the motion to return to our agenda. Eric Levy seconded and all were in favor.

SECRETARY MINUTES- Randall Paz made the motion to accept the minutes from last month's meeting. Eric Levy seconded and all were in favor.

TREASURER'S REPORT- We have a total of \$1788.69 in the Operating Expenses account after \$911.31 was deducted for the derby. There is still \$200 in Professional Development with at least 3 commissioners interested in attending the CACIWC annual meeting. Lisa Lozier made the motion to accept. Randall Paz seconded and all were in favor.

The Farmington River Watershed Assoc. sent both a donation request and a copy of FRWA News.

FISHING DERBY- Roberta had done an outstanding job to coordinate all facets for the event. Sadly, Paderewski pond suffered a major fish kill due to the extremely low water table, lack of oxygen and high temp of the water. The prizes that had been purchased have been put at 50 Whiting St. and all the gift cards were given to Chad and locked in the town safe.

SHED INVENTORY- Roberta reported that the inventory took place on Sept.20th. She will pull a list together to distribute at a later date. One item she mentioned that would be good to purchase is a telescopic net.
