BRD Builders from Hartford was the lowest bidder for the project at \$993,000.00 not counting the add alternatives for kitchen replacements at Centerview (#1 \$47,000.00) and entry and storm doors at Woodmoor (#2 \$180,000.00) This will put the total contract value at \$1,220.000.00. Pending final review of the bid.
