- The Town of Plainville was awarded money from the American Rescue Plan Act (ARPA)
- They have Planning Committee that presented an idea where the money should be allocated.
- They chose the category of "Revenue Loss" they are still in the process of allocating the money, but they did include the PHA in the "Revenue Loss" for \$25,000.00. I do not know if this is going to be approved or not at this time.
- On Tues., February 1, 2022 I had a meet and greet with our new Chief of Police Christopher Vanghele and our Town Council Liaison Rosemary Morante. It was a pleasure it meet both of them.
