Americold is proposing to construct 259,365 square foot refrigerated warehouse for cold food storage at 0 Northwest Drive. This application is a modification of an existing permit that the commission approved in 2018 for Metro Realty, who had proposed a 294,000 square foot for logistics facility, however were looking for tenant and has found a buyer for the property that will change the original proposed layout, however the impact to the upland will only slightly increase from the original proposal.

Americold is currently hiring a new engineer for a concept plan which will be revised and made available for the commission before the February 5th, 2020 meeting.
