#### II. PUBLIC HEARING

1. <u>PZ 01/18 #001 – Zoning Text Amendment – Kristin Brigandi – Amend</u> <u>Section 2.04 Dog Day Care Facilities to Dog and Cat Care Facilities and</u> to allow overnight boarding of dogs and cats.

Ms. Brigandi talked about her plans for her facility. A customer was present to speak. A letter was also received and read into the record by a current customer of Dirty Tails.

Jackie Laramie, 68 Cooke Street Apartment #31 – in favor of the proposed boarding facilities. She is a very happy customer. Her dog is a current doggie daycare client.

Gail Black, 4 Cianci Avenue, in favor of the proposed boarding facilities. She went into Dirty Tails and observed how much the dogs love the staff.

Ms. Brigandi also spoke and told the board that she plans to hire 2 or 3 more employees and also plans to promote current employees to accommodate the addition to her business.

## **IV. NEW BUSINESS**

1. <u>PZ 02/18 #007 – Site Plan Modification – Erfan Mathoxa – Construct</u> addition to rear building at 135 Whiting Street.

The applicant proposes to add on approximately 400 square feet of building to the rear building to allow indoor seating for customers when using the laundromat. The applicant received a variance from the Zoning Board of Appeals for a side yard setback and only require site plan approval at this time. Roof leaders and underground recharge chambers are proposed for the addition. No new parking is proposed as the addition is ancillary to the main business. <u>A motion was made by</u>: A. Chapman to approve a site plan modification for PZ 02/18 #007 for Erfan Methoxha for construction of an addition, at 135 Whiting Street 39-D-01 in a GI Zone.
