#### II. PUBLIC HEARING

1. PZ 02/18 #005 – Special Exception - YMCA/ Jeremy Myska – Modification to a special exception use to construct benches to form amphitheater as part of Eagle Scout Project at 149 Farmington Avenue MBL 15-A-19 in an R-12 Zone (Public hearing must close by 5/1/18)

The YMCA is asking to allow the construction of a moveable amphitheater and seating to be used in conjunction with the YMCA Summer Day camp. The benches will be arranged in an amphitheater style setting with a central stage platform. There will be 15 benches, each with three rows of seats. The amphitheater will be located within the existing bituminous track, away from the neighboring residence properties.

The commissioners asked questions. The applicant explained that the Summer Camp will be utilizing the amphitheater for group activities. It will be stored in the garage at the YMCA for the winter. The YMCA closes at 9:00 PM so no activities will occur after that time. The applicant stated that occasional singing and theater activities may occur up until 7:00 PM. This activity has been ongoing, but will now utilize the amphitheater.

There was no one present from the public. Jennifer Bartiss-Earley closed the public hearing.

#### IV. NEW BUSINESS

1. PZ 03/18 #008 – Site Plan – Gregory Guay – Construct parking and associated site improvements at 10 Sparks Street MBL 23-O-05 in a GI Zone (Decision required by 5/31/18)

The property has been vacant for some time and a light manufacturer has bought the property. In order for the property to be useable, the owner needs to construct a parking lot. The site will consist of 29 parking spaces, with associated landscaping and drainage. The original application showed parking spaces in the required front yard, staff notified the applicant and his engineers that this was not allowed without a variance. The parking was subsequently reduced, although the applicant may still seek a variance and return to the commission for a site plan modification. The existing building does not conform to todays required setback and is considered existing non-conforming.

The commissioners listened to the presentation. Staff provided additional narrative.
