Charles Croce, the civil engineer of the site plan, presented the site plan to the commission. Americold is proposing to construct a 252,115 square foot building on Northwest Drive. The building will consist of refrigerated storage of food products and loading and unloading of refrigerated trailers.

Tom Golarz, Colliers International, presented on the requested increase in building height, citing reduced energy needs and conservation of land.

The IWWC has approved the plan for impacts in the upland review area, staff and the Town Engineer have submitted comments to the engineers and are currently being addressed.
